PESAC is a program of the Government of the State of Amazonas, in partnership with the Military Police (PMAM) and the Department of Education, which aims to promote citizenship, discipline, civic-mindedness, leadership, and meritocracy among students in the public school system. The project seeks to reshape educational management through a civic-military model that promotes a safe and conducive environment for civic education. The central problem questions the benefits of implementing these civic-social projects by the Military Police in Amazonian society. The proposed hypothesis is that, by inserting underprivileged youth into an environment that cultivates discipline and responsibility, the project provides new perspectives for the future, guiding them towards life change through education. The methodology used is an exploratory and descriptive bibliographic survey.

2. SAFE SCHOOL PROJECT, CITIZEN STUDENT

On March 23, 2018, the Military Police of the State of Amazonas (PMAM) participated in a public hearing at the State Legislative Assembly (Aleam), presided over by Deputy Carlos Alberto, to discuss the insecurity in schools linked to the State Department of Education and Quality of Education (Seduc). The Municipal Department of Education (SEMED) also met with The Metropolitan Police Command (CPM) met to discuss challenges related to public safety and the increasing school dropout rate (GOVERNMENT OF THE STATE OF AMAZONAS, POLICE). AMAZONAS MILITARY, 2022).

Based on these discussions, the need for a collaborative solution was identified that It involved different areas, with a clear division of responsibilities and continuous monitoring.

As a result, a joint meeting between the PMAM, SEDUC, and SEMED led to the creation of Safe and Citizen School Project. The Safe and Citizen School Project (PESC) was created through Normative Ordinance No. 001/GabCmt G, dated October 31, 2018, which also approved the Manual for the Project implementation. This project, conceived by Lieutenant Colonel Marcus Vinícius Oliveira de Almeida, Commander of the Northern Area Policing Command (CPA Norte) in 2018, arose...

In this context, on March 10, 2020, through Decree No. 42,036, published in the Official Gazette of the State, the "SAFE SCHOOL, CITIZEN STUDENT PROJECT" (PESAC) was established. involving the State Secretariats of Education and Sports and of Public Security of Amazonas.
