It can be concluded that the legal profession, by leaving its offices and entering the public community sphere, reaffirms its indispensability to the administration of justice and strengthens the democratic rule of law.

This social function is reinforced by the Statute of the Legal Profession and the Brazilian Bar Association. Brazil (Law No. 8.906/1994), which in its article 2, paragraph 1, reiterates that the lawyer provides a service. public and performs a social function. By combining rigorous legal technique in defending legal processes through political and educational action in society, lawyers contribute decisively for the necessary cultural change. The eradication of violence against women is not achieved solely through convictions, but through the building of awareness. A collective effort to respect human dignity, a task in which the Brazilian legal profession is, and must continue to be, involved deeply engaged.

### **5. The intersection between advocacy and social work in the community.**

The complexity of contemporary social problems demands an approach that transcends traditional disciplinary boundaries. The legal profession, when exercised in its social function, finds in Social Services an indispensable partner. The intersection between these two Areas of knowledge are fundamental to guaranteeing the full realization of rights, as the legal demand for a vulnerable citizen rarely comes in isolation; they are almost always the tip of the iceberg of a context of social exclusion, economic hardship, and family breakdown. The OAB Commissions that work in underprivileged communities understand that delivering a legal solution without considering the social support is often an ineffective measure.

The joint effort begins with the screening and diagnosis of the case. While the lawyer identifies the violation of the norm and the appropriate legal procedural remedy; they analyze the socioeconomic context, family support networks, and the individual's basic needs. By example, in a repossession action that threatens to displace a community, the lawyer fights for the suspension of the injunction and for the right to housing is taking place in court, while social services are mapping the situation. Families are supported, children, the elderly, and people with disabilities are identified, and coordination is established with public authorities. Alternative housing options and inclusion in income transfer programs. This synergistic approach enhances results and humanizes the judicial process.

Popular advocacy groups and the Human Rights commissions of the Brazilian Bar Association (OAB) frequently carry out joint efforts in partnership with universities and NGOs that offer multidisciplinary services.
