Summary

This study analyzes the relationship between territory and art education through a comparison between two distinct educational contexts in the state of Indiana, in the United States: Bluffton and Kokomo.

Although embedded within the same state education system, the two locations present significantly different socio-territorial configurations, which are directly reflected in the school environment and pedagogical practices. The research starts from the understanding of the classroom as an extension of the territory, highlighting how factors such as social stability, economic organization, cultural diversity, and access to cultural capital influence teaching time, student behavior, and teaching strategies. The analysis articulates empirical observation with theoretical frameworks that address social space, cultural capital, and systems of meaning.

allowing us to understand the differences between contexts as expressions of structural inequalities. From this perspective, the notion of a pedagogy of adaptation is proposed as a fundamental strategy in art education in environments marked by instability, highlighting the need to reconfigure pedagogical practices to preserve the meaning of the artistic experience. It is concluded that art education cannot be understood in isolation from the social conditions in which it is embedded, and it is essential to consider the territory as a constitutive element of the educational process.

Abstract

This study examines the relationship between territory and art education by comparing two distinct educational contexts in the state of Indiana, United States: Bluffton and Kokomo. The research is grounded in the understanding of the classroom as an extension of the territory, highlighting how factors such as social stability, economic organization, cultural diversity, and access to cultural capital influence instructional time, student behavior, and teaching strategies.

The analysis combines empirical observation with theoretical frameworks that address social space, cultural capital, and systems of meaning, allowing differences between contexts to be understood as expressions of structural inequalities. From this perspective, the concept of a pedagogy of adaptation is proposed as a key strategy for art education in unstable environments, highlighting the need to reconfigure pedagogical practices to preserve the meaning of artistic experience. The study concludes that art education cannot be understood independently of the social conditions in which it is embedded. That territory must be considered a constitutive element of the educational process.

The author argues that "education systems tend to reproduce the structure of symbolic power relations, thus contributing to the reproduction of the distribution structure of "Cultural capital" (BOURDIEU, 1998). This reproduction often occurs invisibly, because through practices, expectations, and evaluation criteria that favor students who already possess, in their family environment, forms of cultural capital valued by the school. In this sense, the Academic performance cannot be understood solely as a result of individual effort, but as an expression of a relationship between the student's habitus and the institutional structures that define what is recognized as legitimate knowledge.

At the same time, the results of this study point to the need to rethink training. teacher, in order to prepare teachers not only for mastery of content and methodologies, but also for a critical reading of the context in which they operate. Teaching art, in this sense, requires skills that go beyond traditional technique and teaching methods, involving the ability to interpret the territory, understand the social relationships that permeate the classroom, and develop strategies that address these conditions.
